

ORDER

No. F.15(1)FD/Rules/2017 Pt.-II

Jaipur, Dated: 12 SEP 2024

Sub: - Grant of Notional Annual Increment to Employees Retiring on 30<sup>th</sup> June -Regarding.

The State Government had decided a uniform date of annual increments for all State Government employees under Rajasthan Civil services (Revised Pay) Rules, 2008 and onward. The employees who had completed incremental period of service under these rules and retired on 30<sup>th</sup> June were not eligible for the increment of 1<sup>st</sup> July, since they were not in service.

The Government has considered the matter in the light of various decisions of the Hon'ble Courts in this regard and decided to grant annual increment to the Government servants who retire on 30<sup>th</sup> June, 2006, and following 30<sup>th</sup> June, thereafter whose increment becomes due on the next day following upon their retirement, and upon completing one year of satisfactory service, shall be granted a notional increment on 1<sup>st</sup> July.

This increment shall be considered as an emolument for pension purposes only and shall not be considered for gratuity, commutation, and encashment of unutilized privilege leave.

The benefit of this increment shall be notional from 1<sup>st</sup> July, 2006, to 10<sup>th</sup> April, 2023, and cash benefits shall be allowed from 11<sup>th</sup> April, 2023 (the date of the Hon'ble Apex Court decision) onward.
